Thank you for entering our trial! Except for the first classes of the day in each ring, all start times are approximate. Dogs in the Master Classes will run, followed by Excellent, and then Preferred Master, and Preferred Excellent. This is a preliminary schedule which is contingent upon the move-up entries that may not have been received yet. The running order is little to big all 3 days.

FAST courses are nested and there will be one walk-through period for all 3 levels.

The building opens 7:30 am Friday, 7 am Saturday & Sunday.

MEASURING: If you need to be measured, please check in to coordinate measuring prior to your run. We will have a VMO both days. Please see me for details.

CRATING: Mats are required to be placed under your crates. Please try to conserve space as much as possible. *Dogs with space issues must be covered and non-disruptive.*

SITE INFORMATION: <u>As always, clean up after your dog.</u> Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may be subject to AKC sanctions.


